WAYS OF STRENGHTENING THE STATUTORY AUDIT EFFICIENCY

ABSTRACT: The integrity of the auditor's opinion and the audit process conducting effectiveness hangs on the professional judgment applied on obtaining, processing and interpreting the internal and external information. Documentation is based on all the audit evidence collected through procedures such as: inspection, confirmation, documentation etc. Audit evidence is used to determine whether the financial statements present the economic reality of transactions and if they faithfully reflect the financial position of the company.
